**QUESTIONS RECEIVED FROM INDUSTRY**

**Q1: We are preparing our response to the RFEI. Will our response be found responsive if we just email our response before the due date, or do we also have to mail in the hard copies as instructed in the RFEI to be found responsive?**

**A1:** As per the RFEI, Section 3, Submittal of Expression of Interest (EOI), MTC requests that “Respondents should submit an original and four (4) copies, as well as one electronic PDF version, of their EOI by *12:00 p.m. PDT on Thursday, May 19, 2016* ~~4:00 p.m. on Friday, May 6, 2016~~, in accordance with the instructions contained in this RFEI.” If a firm does not submit the hard copies by the due date and time, MTC will consider the electronic version submitted by the due date and time listed above.

**Q2: Can the RFEI response due date be extended?**

**A2:** See RFEI Addenda No. 1, item 1. In addition please note RFEI, Section 10.5, Responses to Questions, “Respondents are not required to answer all questions, but Respondents are encouraged to answer any/all questions where they can provide industry insight and/or input.” Also, per the RFEI, Section 3, Submittal of Expression of Interest, “EOIs are requested by the due date and time listed, but may still be considered if received after that date at MTC’s sole and absolute discretion.” Respondents are encouraged to submit EOI’s before or as close to the due date and time listed in RFEI as possible.

**Q3: Section 4, Evidence of Experience, of the RFEI states that experience within North America is required. Does this mean that we cannot participate unless we have references within the North America geography?**

**A3:** As per the RFEI, Section 4.0, Evidence of Experience, Article 4.1, “MTC encourages Respondents who do not demonstrate the evidence of experience listed above to submit an EOI. MTC seeks any and all industry input on technical, commercial, financial, and procurement aspects of MTC’s preferred delivery strategies and on the potential benefits from and challenges of combining large remaining portions of the Clipper® program into one or more DBOM or similar contracts.”
