SOQ, Page 1, Paragraph 2	Interested parties must provide a quote on the attached <u>Quotation Form</u> (<i>Attachment B</i>), based on the attached <u>Qualifications and Scope of Work</u> (<i>Attachment A</i>) by FAX , mail or hand delivered, <i>which must be received by MTC no later than 4:00 p.m., June 15, 2012.</i>
2.	SOQ, Attachment A, Section II, Scope of Work, Subsection A., Paragraph 1.	Clean and wash building exterior windows using the Bosin's chair method <i>with contractor's own appropriate, safe equipment and devices and in compliance with all laws and regulations</i> , on first, second and third floors, wipe down metal doors on 7 th Street side of the building, and clean tracks of sliding doors.
